Introduction

This report documents the final design, process, and decisions of the database for the Robert Addison Library Web Catalogue. For a detailed explanation of the design process with commentary on each iteration, please visit the project design blog: www.neil-macdonald.com/RAL_project/.

Included in this report are a process description, assumptions and limitations, business rules, a sample of pre-normalized data, normalization with end-user's relational schema, a complete entity relationship diagram, entity-attribute tables, sample data, and sample reports.

The purpose of this report is to explain the final design decisions and show the structure of the database, so that users can better understand how the catalogue works and to provide a blueprint should anyone wish to expand upon or update the database in the future.

Process Description

To begin this design, I reviewed the original print catalogue and the Excel spreadsheet with expanded notes on which Donald Combe, Peter Babcock, and I worked. This gave me a clear idea of what data is available to work with. Earlier in the project process, I had already conducted end-user UX design and information architecture¹ so I had already assessed the types of data users wished to access and how.

From this review, I created a table of all available data and fields. This table then went through a few iterations as I removed repeating, redundant, and/or unnecessary data. Eventually, I had a table which was sufficient to work from.

I then proceeded to write the business rules. Based on the user needs assessments conducted in the original UX design work and the recently created table, I was able to create a set of business rules. During the design, the business rules were edited or modified slightly as I determined some things were unnecessary or would require a re-cataloguing of the collection. For notes on these decision, please see the business rules.

While many entities and their related attributes were identified during the initial data review, the business rules helped me identify relationships and constraints among the entities and attributes.

The normalization process came next. Moving through 1NF to 3NF, I was able to identify many-to-many relationships and create the necessary bridging entities. During the normalization process, I identified and created (auto-generated serial numbers) primary keys, foreign keys, and removed more redundancies.

The entity relationship diagram (ERD) went through six iterations before I arrived at the ERD shown in this report. I spent more time developing the ERD than I had originally budgeted, but I felt that the extra investment of time at this stage was crucial and would make the rest of my work run more smoothly.

Once the ERD had been finalized, I used the original table to create a small set of sample data (23 titles) and entity-attribute tables. The entity-attribute tables appear before the sample data in this report to aid readers in understanding the sample data.

Sample data was then used to create sample reports illustrating what a user may be able to find when conducting specified searches.

After building the database, inserting sample data, and running a series of test queries, some improvements in the design presented themselves. The database was then redesigned and I began putting together a larger set of sample data (500 titles). While creating this larger sample set, I discovered some new data types and relationships, which prompted another redesign. This report has been updated to reflect those changes.

Assumptions and Limitations

A number of entities and attributes could have been included in the main Title table, but due to the large number of null values this would create, it made sense in the name of efficiency to split these attributes off from the main table and make them entities of their own.

Alternate_Catalogues is one such entity. The titles in the catalogue have been catalogued and assigned catalogue numbers by others. The other catalogues referenced in the original Robert Addison Library Catalogue are:

- STC or Short Title Catalogue
 - A list of books printed in England, Scotland, and Ireland from 1475-1640
- WING (created by Donald Wing)
 - A list of books printed in England, Scotland, Wales, Ireland, and British America from 1641 to 1700
- C&C (created by William J. Cameron and Diana J. Carrol)
 - A list of English books printed in the British Isles and colonies from 1701-1800
- Madan (created by Falconer Madan)
 - A list of books printed in or related to the University and town of Oxford (1468-1680)
- Willems (created by Alphonse Willem)
 - A list of titles printed by the Elzevier family, a famous Dutch family which ran a print company from the early 17th though 18th centuries

Many books in the Robert Addison Library have no corresponding STC, WING, C&C, Madan, or Willems number; however, many do and while STC, WING, C&C and Willems are mutually exclusive, some titles have a Madan number and an STC, WING, or C&C number.

In order to improve the efficiency of the database, these attributes were put under their own entity: Alternate_Catalogues.

The STC (Short Title Catalogue), WING, and C&C cataloguing systems have been superseded by the ESTC (English Short Title Catalogue), which was begun in 1976. The original cataloguing of the Robert Addison Library was done in 1967 before ESTC had even been conceived. I decided during the designing of the database, to not include ESTC as the time commitment to do the research required for this would delay the project too long.

While it would be preferable to include this data in the catalogue from the outset, I am willing to return to this project in the future and update the database with ESTC numbers if and when they have been determined for each book in the collection. I cannot allow perfect to be the enemy of good.

The Images and Notes entities were also created to eliminate null cells in the Title entity.

(Subject) Headings could have been put in a separate table and some early designs had headings separated for the sake of efficiency and to reduce the chance of a human data entry error in the creation of the database. However, a heading had already been entered into the original Excel table for each title, so putting the headings in the title table turned out to be the most efficient design.

The Printers and Printers_Titles entities was created because not every title has a known printer and some printers have printed multiple titles in the collection. This is not a many-to-many relationship and does not require a bridge entity, but without a bridge entity, I would have to re-type a printer's name for each title and this increases the chance of a data input error. By creating separate tables for printer names and printer-title relationships, I am able to reduce the risk of error.

Translators and Editors share zero-to-many relationships with Titles and were separated with bridge entities for the same reasons as Printers and Printers_Titles.

The Authors and Provenance tables shared many-to-many relationships with the Title table and required bridge entities.

Pre-normalized Data

The following image is the final version of the pre-normalized data taken from an Excel spreadsheet. The data went through a few tables and spreadsheets before this representation was chosen to work with.

As is immediately visible, there are many cells with null data. Further iterations of the design eliminated these.

Business Rules

“Title” refers to the title of a book and each title will represent one record in the database.

- Identifiers
 - Each title has a unique identifier
 - Each title has an Addison Library number (AL No.)
 - Each title was either purchased in England or not (original AL No. or not)
 - Each title has zero-to-one STC code (Short Title Catalogue)
 - Each title may have zero-to-one WING numbers
 - Each title may have zero-to-one C&C numbers
 - Each title may have zero-to-one Madan numbers
 - Each title may have zero-to-one Willems numbers
- Authors
 - Each title has one or more authors
 - “anonymous” is used if a title’s author is unknown
 - Each author has one or more titles
 - Some authors have titles/honorifics (e.g. Bishop, Duke, Saint, etc.)
 - Some authors have middle names
- Books
 - Each title will have a book
 - Each book will have one-to-many titles
 - Some titles are bound with other titles
 - All books are shelved under an AL No.
 - Books containing multiple titles are shelved under the first AL No. to appear in the book
 - Each title has one measurement for width and one for height
 - Each title can have zero-to-many associated images
- Printing
 - Each title has zero-to-one printer/publisher
 - The printer/publisher is not identified in all books published during this period
 - Each printer has one-to-many titles
 - Each printer has zero-to-one address
 - Each title has a publication date
 - Each title has a printing method
 - 4o quarto, 8o octavo, 12o duodecimo, 16o sextodecimo, fol(io)
 - most titles have an imprint detailing the title’s production history
- History
 - Each title has zero-to-many provenance entries
 - Provenance entries have zero-to-one date
 - Provenance entries have one-to-many titles

- Each title has zero-to-many notes
 - Notes describe things that are unique to an individual copy of a book (e.g. damage to the book, date and location of purchase, provenance, etc.)
- Each note corresponds to one title
- Subject
 - Each title has one subject heading
 - Subject headings have one-to-many titles
- Images
 - Most titles have at least one image of the title page
 - Some titles have multiple images
- Translators
 - Some titles have been translated into English and the translator is known
 - Some translators have translated more than one title
- Editors
 - Some titles have been edited and the editor is known
 - Some editors have edited more than one title

Entity-Attribute Tables

The following entity-attribute tables are intended to provide an explanation as to the different types of data in each table so that users and any designers who do work on this database in the future will be able to understand the nature of the data and why it has been organized this way when looking at the normalization process and ERD.

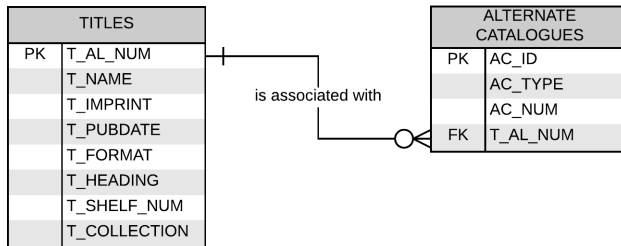


Figure 1 Alternate_Catalogues in 3NF

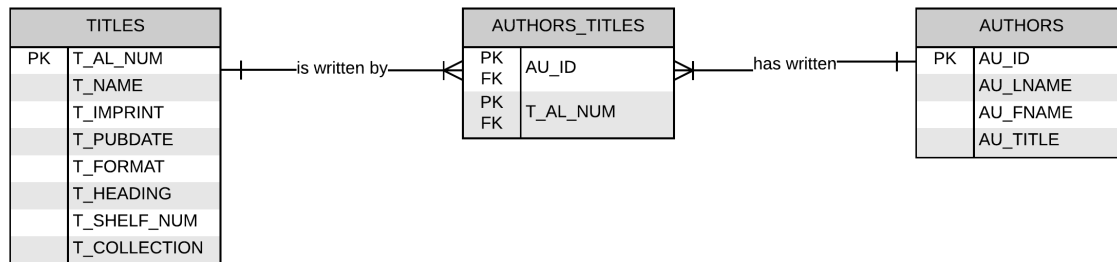


Figure 2 Authors_Titles in 3NF

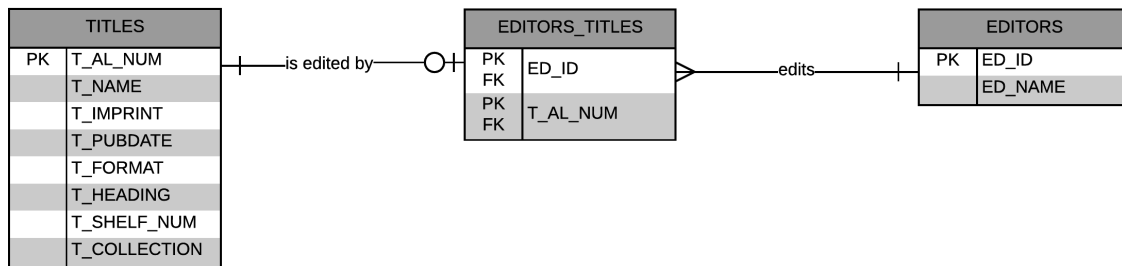


Figure 3 Editors_Titles in 3NF

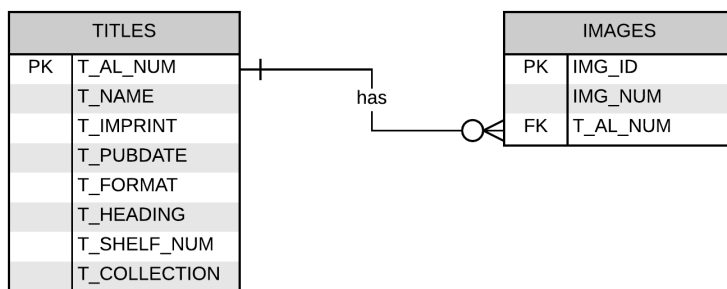


Figure 4 Images in 3NF

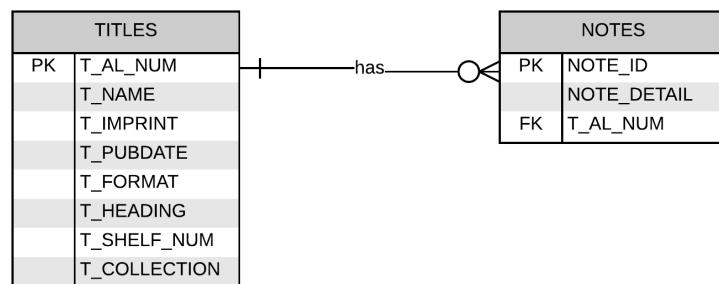


Figure 5 Notes in 3NF

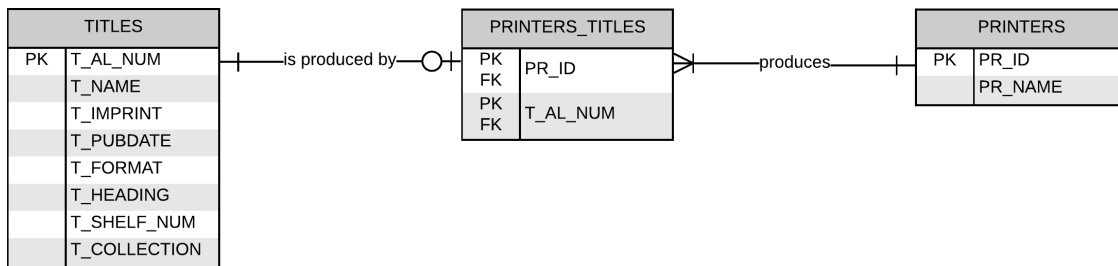


Figure 6 Printers_Titles in 3NF

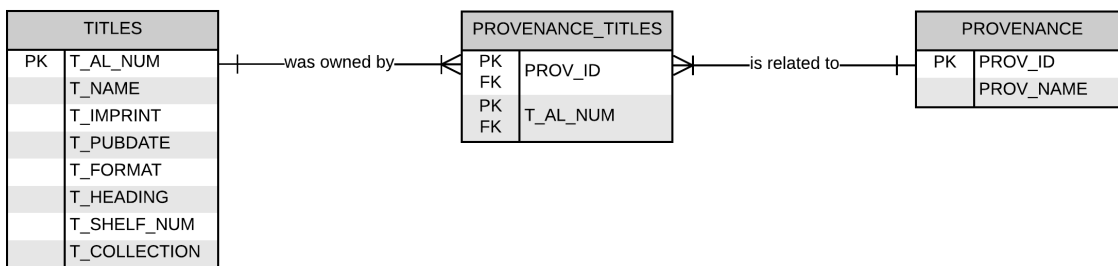


Figure 7 Prov_Titles

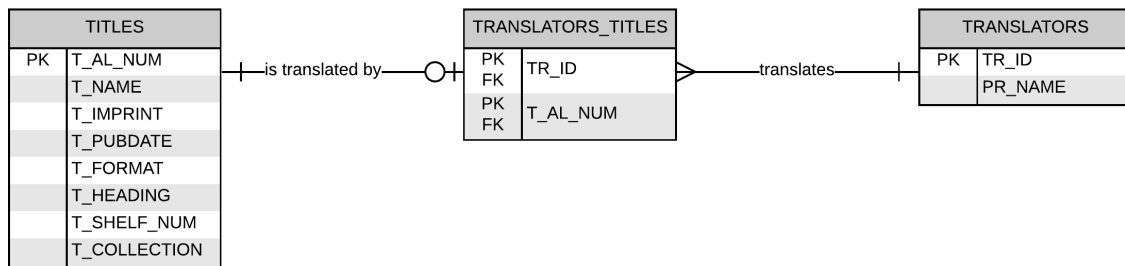


Figure 8 Tranlators_Titles in 3NF

Process: This particular result could have been achieved in many different ways. First, by querying T_Name for this specific title. Secondly, by querying T_AL_Num for this specific number. Thirdly, by querying Alternate Catalogue for Ac_Type STC and Ac_Num for 1128. Fourthly, there are many combinations of search criteria that could have yielded this result, such as Au_Lname and T_Pubdate.

Note: It is the intention of the Robert Addison Library Web Catalogue to be able to display images of the titles, but since that is not a feature of the database itself, I chose to represent the query result as it would appear in the database, not through a web interface.

Conclusions

This database represents the data collected in the original Robert Addison Library short title catalogue produced in 1967 by William J. Cameron, George McKnight, and Michael-Sue Goldblatt as well as additional research done by Donald Combe, Peter Babcock, and Neil MacDonald.

By following process-centered DBMS development and design standards, I have produced a functional 3NF database design and the corresponding professional documentation.

It is my hope that further research will be done on the library's collection and that this report will be of use to any future expansion of the Robert Addison Library Web Catalogue.
